NOMINATION APPLICATION FOR CLASSES ENTERING THE ACADEMIES

APPLICATION DEADLINE: OCTOBER 1, 2013

Each year members of Congress nominate young men and women to become eligible for an appointment to a U.S. Service Academy. The academies are seeking future cadets and midshipmen who possess “whole person” qualifications - good moral character, a commendable academic record, evidence of strong leadership potential, physical aptitude, medical fitness, motivation to achieve academically and eventually to serve as an officer in the Armed Forces. Later this year I will make ten nominations for each Seventh Congressional District vacancy at:

- The United States Air Force Academy, Colorado Springs, Colorado
- The United States Military Academy, West Point, New York
- The United States Naval Academy, Annapolis, Maryland
- The United States Merchant Marine Academy, Kings Point, New York

My nominations will be based on the recommendations of my Merit Selection Committee which is made up of community representatives from Colorado. The nominating process begins with the accompanying application packet. **All required forms and documents must be on file in my office by October 1, 2013.** If your file is complete at that time, you will be scheduled for a personal interview with my Merit Selection Committee. Interviews will be held in November at my Lakewood District Office and I will announce the nominations before the end of the year.

After my nominations have been submitted to the academies, the Admissions Office of each academy will offer the actual appointments to successful nominees. The announcement of appointments can begin as early as January and will continue for several months until the ranks of the next entering classes are full.

Because the nomination process is extremely competitive, be sure to apply to all nominating sources available to you. Also, you should indicate your alternative academy choices in case you don't receive a nomination to your first academy choice. Give yourself the benefit of every opportunity. Please read this application packet thoroughly and follow instructions carefully. Please don't hesitate to call my office with any questions or concerns.

SERVICE ACADEMY NOMINATION REQUIREMENTS

To be eligible for an academy nomination from the Seventh Congressional District:

You must be:

1. A legal resident of the Seventh Congressional District of Colorado;
2. Between the ages of 17 and not yet 22 on July 1st of the academy class entering year;
3. A graduate of high school before July 1st of the year of the entrance to an academy.

You must submit the following documents to my Lakewood office before **October 1, 2013**:

1. An official application with photo attached. Do not substitute this form with a resume;
2. Concise (one page) answers to essay questions;
3. Two personal letters of recommendation from teachers, employers, community leaders, church leaders, scouting, Civil Air Patrol, JROTC leaders or other adults who know you well (These two letters are in addition to the counselor's information on the school form).

You are responsible for directing the following documents to arrive at my office before the September deadline:

1. The school recommendation form (found in this packet) which must include your high school transcript bearing the official seal of your school or the signature and title of a school official;
2. Your ACT (including the essay test) or SAT scores (to apply, you **MUST** have one or the other by the deadline).

To be eligible for a Congressional nomination and eventually to be eligible for an appointment to a U.S. Service Academy, you **MUST** follow two procedures at the same time:

Your answers to these questions, combined with your application and all other official records and documentation, will provide my Merit Selection Committee with the most complete information to determine your suitability for an academy nomination.

Your answers should reflect YOUR OWN BELIEFS and CONVICTIONS, not just what you think someone else might want to hear. Feel free to do research. The CONTENT of your answers is of greatest importance; however grammar, spelling, punctuation and writing style will also be considered.

Please limit your answers to one (1) page single-spaced and answer all three questions. When completed, attach your three essay pages to this cover page with a paper clip, and return it with your application.

Please print the numbered questions with your answers on three separate pages.

- 1. Describe a leadership experience you have had (sports, clubs, scouts etc.) and what you learned from that experience. (If you have not been a leader, describe a learning experience you had as a “follower” in one these activities.)**
- 2. Since the military also commissions officers through the Reserve Officer Training Corps and Officer Candidate programs which can take as little as ninety days to two years to complete, why do you think the United States operates military academies that require four years to complete and that cost many thousands dollars per cadet or midshipmen per year?**
- 3. Cadets or midshipmen who enter a service academy have typically been among the highest achieving young adults in sports, academics and leadership in their local communities. Where do you think you would stand in each of these areas among your peers and what attributes and strengths do you have that would allow you to attain high levels of achievement as a cadet or midshipmen?**
